Main Theme: Urban Governance - The Evolving Urban Agenda of U20 Cities

This Special Issue will explore governance approaches, urban policy frameworks, and transformative strategies shaping Urban20 cities across the globe. With contributions from academics, policymakers, civil society, and government officials, the issue will foster critical discussions on equity, resilience, digital transformation, financing mechanisms, and climate action. The Special Issue aims to bridge research, policy, and practice within urban governance contexts, particularly aligning with the Urban20 (U20) governance agenda. Furthermore, its intention is to encourage practitioners to collaborate with academics on joint writing projects, with emphasis on multi-disciplinary research to create a body of knowledge to assist decision-making and service delivery in local government.

Selection of Papers

Selection of papers will be on the basis of: Thematic Alignment and Relevance, Originality and Innovation, Academic Rigor and Clarity, Policy and Practical Implications; and Contextual Sensitivity.

Abstract Submission Requirements - Urban20 Special Issue

To ensure high-quality and thematically aligned submissions, abstracts must meet the following criteria:

 Topical relevance: must clearly address the main theme and at least one sub-theme outlined in the call.

- Urban African focus: at least part of the analysis must focus on urban governance in Africa or offer comparative insights relevant to African U20 cities.
- Clarity and contribution: clearly state the research question, urban challenge, and expected contribution to knowledge or policy. Indicate relevance to U20 city priorities.
- Analytical and policy value: briefly mention the methodological approach and potential policy insights or innovations.
- Format

Abstracts will be rejected if:

- Off-topic or too generic
- Lacking analytical focus or policy relevance
- Poor language or formatting

Submission Guidelines for Authors

Abstract submissions should include the following information:

- Topic/Title
- Author(s) Full Names, Affiliation, Email Address(es)
- Abstract Content and Length: should contain an abstract of 150 words
- Keywords: Each abstract should contain between 3 and 6 keywords
- File Format: Submit abstracts in MS Word format
- Language: Abstracts must be written in English
